More than 40 volunteers joined our Nuns on the Run City2Surf team and braved the cold and windy weather to walk the 14km from Martin Place to Bondi Beach to raise money for Gorman House.

Nuns on the Run raised over \$18,000 to help Gorman House keep its doors open seven days a week, 365 days a year. Gorman House provides vital drug and alcohol detoxification services to over 1,500 people a year, some of whom are amongst the most marginalised members of our community. In fact, more than half the people helped by Gorman House are homeless.

# **Community Grants Program**

#### **Prison Fellowship Australia**

The experience of having a parent sent to prison can be very traumatic for a child. The trauma of separation is often compounded by the absence of good role models in a child's life.

Thankfully, the South Australian branch of Prison Fellowship Australia has designed a program called Camps for Kids which targets the primary school age children of prisoners.

Specially trained youth leaders engage children in many fun and challenging activities as a means of communicating important values such as respect, honesty, manners, team work and trust.

Financial support provided by the Sisters of Charity Foundation will enable children aged between eight and eleven to experience activities such as rock climbing, canoeing, archery, trampolining and BMX riding.

For some it will be their first ever 'holiday' and for all of the children involved it will be a positive learning experience.

The Maslow's Need to Feed Program

Homeless people, and those on the verge of homelessness, struggle with life's basic necessities. That's why the Dandenong Ranges Emergency Relief Service has established a drop in centre. It provides a safe space where people can go and receive compassionate assistance and advice.

The Sisters of Charity Foundation provides important financial support to the Maslow's Need to Feed Program run at the Dandenong Ranges Emergency Relief Service. Our support means that people in real need can be given basic, practical provisions such as tuna, bread and pasta sauce.

### UnitingCare Casino Transport Team

Transport to and from essential medical appointments can be expensive and difficult if public transport isn't readily available. However, the people in the Casino and surrounding areas have benefited from the much needed UnitingCare Transport Team services.

Since 1999 UnitingCare have been offering free transport to those in need and the elderly, many of whom would otherwise become isolated and housebound.

With the financial support of the Sisters of Charity Foundation people on low incomes in and around Casino can now be readily transported to Lismore or the Gold Coast for specialist medical treatment.

# The Sisters of Charity Bequest Program

Asking people to consider their end of life arrangements is never easy or comfortable and it's something most of us prefer not to think about. In fact, nearly 1 in 2 Australians do not have a valid Will in place, which often makes it difficult for those close to them to honour their wishes.

However, experience has shown us that people often choose to give something to an organisation they respect, or has helped them over the course of their life, after they have made arrangements for loved ones and those nearest to them.

For the first time, the Sisters of Charity Foundation will be inviting our donors and friends to consider making a gift that will be dedicated to enable those plagued by disadvantage to build a brighter future for themselves and those they love.

# The Sisters of Charity Foundation Scholarship (Aikenhead) Program

The Sisters of Charity Foundation Tertiary Scholarship program continues to go from strength to strength.

Since the beginning of 2012 the Foundation has offered university scholarships to disadvantaged young people who have lived in out-of-home care.

Sadly, only around 2.8% of young people who have lived in outof-home care will go onto university compared to around 40.4% of young people in their early twenties.

Our scholarship program is working towards turning this around. We have already created five scholarships at Australian Catholic University and The University of Notre Dame, Australia. We will build on this result in 2013 with scholarships to commence at The University of Sydney, The University of Queensland and negotiations for the establishment of a scholarship are also underway with The University of Melbourne.

Here's what one of our scholarship recipients told us recently:

"I would like to thank and show my appreciation to every single person who has made this opportunity possible for me, I will forever be grateful and you can be assured I do not take this privilege lightly. I think about all of you and all of the people who would thrive as well, if given the same chance, and that is what gives me the courage and strength to push through especially in the difficult times."

Education gives people the skills required to build a better, more fulfilling life for themselves and their loved ones. The Sisters of Charity Foundation is committed to creating more life changing opportunities for disadvantaged young people in the coming year.
