Demonstrate academic or personal achievements, commitment, and motivation to study and to successfully complete the course, and to gain employment

Correctly complete this application form and attach all supporting documents as indicated

Include a personal statement in support of their application (section 8 of this form), indicating how they believe the scholarship will assist them with their studies and in their future career. This statement should give a sufficient explanation of the applicant's background and current circumstances, enabling the assessment committee to judge their eligibility, need, and merit

Be willing to provide the Foundation with reports on their progress. These may include a written report once a year, a survey and informal conversations throughout the year.

#### **Terms and Conditions**

#### 1. Introduction

You must read these terms and conditions in their entirety before you submit your scholarship application. When you submit your scholarship application, you are agreeing to and accepting these terms and conditions and any other requirements.

#### 2. Accepting your Scholarship

Students offered the scholarship will receive a scholarship offer pack, containing a scholarship recipient agreement (offer letter), as well as these terms and conditions. You will be advised in your offer letter on how to accept or reject your scholarship.

If you do not complete the acceptance as instructed, your scholarship may be withdrawn and/or reallocated.

#### 3. Communication

It is your responsibility to keep your contact details up to date. All correspondence during the application process will be sent to the email address submitted in your scholarship application. Please provide a valid email address. Check this email account at least weekly and ensure there is space to receive emails.

#### 4. Scholarship Criteria

Scholarships are awarded based on established eligibility and selection criteria. You must meet the requirements to receive your scholarship payment.

#### Applicants must:

- be Australian citizens or permanent residents;
- be enrolled, or intending to enrol, at a tertiary institution;
- currently be in out-of-home care, or have previously been in out-of-home care;
- demonstrate that they are experiencing educational disadvantage and financial hardship;
- demonstrate academic achievements, commitment and motivation to study and to successfully complete the course to gain employment;
- correctly and fully complete the appropriate application form, submitting it by the closing date;
- include a personal statement in support of their application, that indicates how they believe the scholarship will assist them with their studies and in their future career. This statement should give a sufficient explanation of the applicant's background and current circumstances, enabling the Sisters of Charity Foundation to judge their eligibility, need, and merit;
- be willing to provide the Foundation with reports on their progress. These may include a written report once a year, a survey and informal conversations throughout the year.

## **Terms and Conditions** (continued)

#### 5. Method of Selection

- Successful applicants will be selected based on their written application, academic potential, and their ability to meet the criteria.
- Shortlisted candidates may be required to attend an interview.

#### 6. Scholarship Conditions

To retain your scholarship, recipients must:

- maintain satisfactory academic performance as well as an active enrolled status in your course of study at your chosen tertiary institution. Your scholarship may be terminated if your enrolment status becomes inactive;
- maintain satisfactory attendance levels and submission of assignments or other assessment methods for purposes of determining your course progress. Your attendance, course progress, and eligibility will be reviewed prior to each payment;
- adhere to the academic and administrative policies at your chosen tertiary institution, including policies regarding student discipline;
- adhere to the terms and conditions within this document.

If any of the specified conditions are not met, recipients' status and continuation of the scholarship will be reassessed and determined by the Sisters of Charity Foundation. If we determine that you do not meet the scholarship conditions at this, or any other time, your scholarship may be suspended, pending further investigation, or be terminated.

If you are offered a scholarship, your scholarship details may be passed on to your faculty. Details of the selection process, or reasons you were awarded the scholarship, will remain confidential.

#### 7. Scholarship Value

- The total value of the recipient's scholarship will be outlined in the recipient's offer letter.
- The value of the scholarship is \$30,000 over the duration of the recipient's undergraduate degree.
   If the degree is for three years, up to \$10,000 per annum is paid from the total scholarship value towards the cost of tuition fees, educational and living expenses. For a four-year degree, up to \$7,500 is paid per annum.
- Funds may be applied to expenses at the discretion of the recipient e.g. course fees, books and texts, uniforms and material costs, and living expenses.

#### 8. Payment of Scholarship Funds

- · Scholarships are not retrospective.
- Payment of funds will be processed once the student has been verified as having enrolled in the

- nominated course, and having exhibited satisfactory attendance and/or participation in the course. Processing will commence within four weeks of the course commencement date.
- You may be required to nominate an Australian bank account. Each semester, your scholarship money instalments will be transferred, via direct debit, into this account.

#### 9. Scholarship Duration

Your scholarship will end once you have been paid the total scholarship value, or if your scholarship is terminated under these terms and conditions.

If your scholarship is terminated, you will not receive any further payments. You may be required to repay some, or all, of the scholarship monies paid to you, if you have failed to:

- provide complete, true and correct information in this application;
- maintain an active enrolled status in your course of study;
- maintain satisfactory attendance levels and course progress;
- adhere to the academic and administrative policies of your chosen tertiary institution, including policies regarding student discipline;
- adhere to the terms and conditions outlined within this document.

#### 10. Assignment

You may not assign any rights you have under the scholarship.

#### 11. Appeal

The decision of the assessment committee is final. There are no appeals for unsuccessful scholarship applications.

#### 12. Media

You may be asked to provide brief updates to the Foundation that can be used to promote the Foundation's scholarship program. This is voluntary. If you are happy to help the Foundation in this way, you will be asked to sign a media release and consent form. Consent can be withdrawn in writing at any time prior to the publication of these marketing materials.

#### 13. Privacy

The personal information you supply to the Sisters of Charity Foundation on the scholarship application form will be used to assess your eligibility for scholarships. Other purposes of information collection include dealing with administrative matters in relation to your application, corresponding with you, and the compilation of statistics. Your privacy will be respected at all stages of the process.
